

The assets are invested mainly in publicly traded equities and equity-linked securities whose issuer is a company based or listed in the USA. The investment strategy is passive. This means that the investments in the portfolio reflects the benchmark index. The assets are invested directly in a selection of equities included in the benchmark, using a model designed to reduce trading costs and minimise tracking error. As an investor, you can expect that the return in general corresponds to the development in the benchmark index.
